Our process for copyright permission requests involves locating the physical item and then we try to determine if the copyright holder is known. Based on that information we will see if we think we are in a position to provide permission or refer you to someone else if necessary. If we do provide a permission letter we send it as an email attachment on university letterhead and signed by the University Archivist.

I will add your request to my scanning queue. We are usually able to answer requests within 2 weeks. If you are under a deadline please let me know the date.

To provide the letter from you we need:

- Title or working title of publication or project
- Author or creator
- Publication date
- Name of Publisher
- Online, print or both?

Hello Angela,

I looked through all the folders within the Paul C. Schroeder Papers that cover the 1968 time period and did not find anything with the title you mention. If you send me a scan of the item, or maybe just the first page if it's multiple pages, I can take another look.

Based upon the type of material I was seeing in the series, my guess is that the University would not own the copyright. If you can identify an author for the item, the author would be the copyright holder. If the author is no longer living, the rights usually fall to the closest living relative.

You could also consider whether your use would fall under Fair Use in U.S. Copyright Law. For a guide that can help you make your own decision, look at the "Fair Use Checklist" issued by Kenneth D. Crews of Columbia University: <https://copyright.columbia.edu/basics/fair-use/fair-use-checklist.html>.
